



SMART IRRIGATION CONTROLLER PROGRAM

PURPOSE: To reduce the amount of landscape water used by AMWC customers and improve landscape irrigation efficiency by utilizing weather-based irrigation controllers as a tool to improve irrigation management.

REBATE: Upon installation of a qualified Smart Irrigation Controller (SIC), customers will receive a rebate up to 50% of the actual price paid for the WBIC, with a maximum rebate of \$100. The refund will be applied as a credit to the customer's account.

EXPIRATION: This application expires 120 days from the date of pre-inspection or when funds run out, whichever is earlier.

SMART IRRIGATION CONTROLLER REBATE PROGRAM TERMS & CONDITIONS

REBATES ARE SUBJECT TO THE FOLLOWING TERMS AND CONDITIONS:

- Qualified Smart Irrigation Controllers must be EPA WaterSense labelled. Look for the EPA WaterSense label on the box or cover of the Smart Irrigation Controller(s) you purchase. Visit the EPA WaterSense website to search products.
- Rebate does not include tax, delivery, or labor.
- Applicant must have a current, active account with AMWC in good standing.
- The application must be **completely and accurately** filled out.
- All rebates are subject to both pre and post-inspections. Sites must be pre-approved by AMWC Conservation Staff before any work is started in order to be eligible for a rebate. The program is not retroactive.
- Only one rebate is paid per owner per property. If you are a tenant, written permission to receive the rebate must be obtained in writing from the property owner.
- Retain a copy of this application and the sales receipts for your records.
- A credit of \$100 will be applied to the Shareholder's water account.
- Shareholders are advised that "before" and "after" photos of the landscape may be used for AMWC marketing and outreach.
